Call to Order

1. CALL TO ORDER (7:06 p.m.)

Board of Education President Gregory Miglino, Jr., called a Workshop Meeting of the Board of Education to order at 7:06 p.m. The meeting took place in the Boardroom of the Central Administration Building, 189 No. Dunton Avenue, East Patchogue, New York. Long Island Advance and South Shore Press were notified of this meeting. Notices were also sent to all school buildings and the local libraries.

2. PLEDGE OF ALLEGIANCE

Board Vice President Carl Moodt led the Board and all others present in the Pledge of Allegiance.

Public Participation

4. PUBLIC PARTICIPATION

Resident: Q re: the hearing scheduled for next Tuesday re: Toni Huffine?

Gregory Miglino: the Board will not be taking questions pertaining to the hearing

Toni Huffine: stated that she is waiving her rights to privacy and would like this matter addressed in the public forum.

Gregory Miglino: answers to questions pertaining to this matter will be 'restricted'.

Resident: Q re: why the Board did not ask for an officer from the State Education Department to hear the case?

Gregory Miglino: The Board is following the legal structure set forth by the State Education policy, using the most expeditious way to resolve these issues...

Resident: Q re: the identity of the hearing officer that was selected? Q re: the amount of money that will be spent?

Gregory Miglino: the hearing office is someone who is known in the education field and was recommended to the Board; the Board does not know this individual; response to Q re: amount of money that will be spent: amount not known; to date the district has spent \$2 thousand.

Mark Grossman: [resident and former member of the Board]: read a prepared statement: expressed "utter disgust" with the actions of this Board; spoke of the special board meeting held this past Friday; said it was "for the sole purpose of acting on a single resolution to bring charges against Board member Toni Huffine and to schedule a hearing to be held next week with an impartial hearing officer appointed by the Board."; also said that the hearing officer chosen is a person who several years ago, served as attorney for this school district and was terminated by the Board; does not believe this person can be totally impartial; spoke of the "supposed" theft of campaign signs - stating that "campaign activities are civil, non-official matters; referenced the other charges made against Mrs. Huffine – said the Board should "stop the witch hunt because it is a distraction from the real issues" and "it is persecution and harassment"; spoke about the Board being "very good at convening last-minute emergency meetings in the early morning hours to discuss dumping someone – whether it is a superintendent or a Board member".

Resident: Q re: the origin of funds used for defense fees and if it is from tax dollars? Q re: whether the use of these funds is classified as school business?

Gregory Miglino: acknowledges that this money is coming from tax dollars; and that a certain amount of money is budgeted for legal fees.

Jeanne Steck: spoke of student assessments and the importance of having TAs in a classroom to assist the teacher; also spoke of the new program and said negative results will be seen over time.

Gregory Miglino: the Board took action based on our financial situation; we are restricted by the adopted budget but hope to find a resolution for this issue next year.

Carol Kelly: [teacher and resident]: Q re: grant money from Reading First used as partial funding for TAs salaries? Q re: if the Board did not know other arrangements had to be made as the grant was approaching its end date? said that not meeting the needs of students is unacceptable, and that she personally encouraged everyone to "go out and vote for the budget".

Gregory Miglino: eliminating TAs was not done as a cost-cutting measure; the Board was misled by the numbers on the budget that was put forth for adoption.

Barbara Schatzman: everyone is upset about the issue with the TAs; believes that the remaining TAs should be utilized for early intervention – not push-ins

Joe Cipp: is discouraged about teachers' attitudes and statements such as 'our students are headed for failure'; said this approach to the problem is not acceptable and that it sounds like teachers are saying that they are giving up.

Toni Huffine: [in response to Joe Cipp]: “this is not sports – this is teaching Kindergarten and Fist graders” – one class has “at least twenty-four students at once, who need to have their boots put on, finding their lunch money”....etc.

Gregory Miglino: told Toni Huffine that she too, voted in favor of eliminating TAs.

Toni Huffine: said that she did not vote in favor of eliminating TAs.

Barbara Schatzman: spoke of what working with kindergarten and first grade students entails; said teachers can do their jobs, but that more can be done with an extra set of hands.

Gregory Miglino: reiterated that every vote that was taken on this issue was passed unanimously.

Michael Bilecki: said this is the fault of the Board, and that this Board is a “dysfunctional group”; spoke of money being used to defend Board members against Board members, and the Board being more concerned about what is going on among themselves; asked the Board to find an investigator to figure out what is causing the dysfunction among themselves.

Gregory Miglino: disagreed with Mr. Bilecki; said positive changes have been made; spoke of hopes for an offset to the budget; said the district is working diligently to find solutions and that staff is coming in early and leaving late, working with the State and attending meetings with our elected officials in hopes of finding a solution to the problem; said we are doing the best we can within the confines of the law

Resident: spoke in defense of teachers; referenced Mr. Cipp’s statement about teachers sounding like they are giving up.

Marian McKenna: Q re: the number of TAs prior to the Reading First grant? and, Q re: whether incremental replacements will be made if money is found?

Gregory Miglino: nine [9] TAs are needed to equal the total prior to the arrival of Reading First.

Richard LeBrun: in reference to Mrs. Huffine’s case: believes it would be prudent to wait for the District Attorney to come back with a decision before actually conducting the hearing, and that if Mrs. Huffine appeals the decision, the \$2 thousand dollars that has already been spent will be a drop in the bucket; said he spoke with a board member from another district who had a similar situation, and that their legal bills amounted to \$80 thousand.

CONTINUED DISCUSSIONS RE: LEGAL FEES AND COST TO TAXPAYERS

Lisa: parent of autistic child: addressed the Board about arrangements with the previous bus company for transportation to a daycare in Flanders – said she spoke with Mr. Buzzo and was told the problem was resolved, only to find out on the day of the scheduled pickup that transportation will not be provided; also said that she was not spoken to in a respectful manner and that she was told that transportation to Flanders was illegal.

Superintendent Walsh: said he was not aware of the special transportation arrangements; said the cost of making this special run will cost the district \$21 thousand; apologized to Lisa, if she felt she was spoken to in a disrespectful manner.

5. WORKSHOP DISCUSSION**A. District-wide Security**

Superintendent Walsh opened the discussion on Building Security:

- Uniforms, qualifications criteria and securing building entries
- Asked Board members to state their expectations

Discussion re:
District-Wide
Security

Q & A: Board Members and Superintendent Walsh:

- Board Member - Q re: who is here after hours if something occurs?
- Response – Ray Walsh: I will be called if an alarm sounds
- Board Member: would like to have weekend security to guard our fields and playground equipment – graffiti on FPL school, residents using the fields for playing ball; Cameras and lighting for the outside of the building – all equipment covered under the Bond project – cameras are already purchased; considering immediate installation [Bond Committee Chair]
- Ray Walsh: would like to put in place, concrete plans for security staffing
- Board Member: Administrators and teachers are most important; need ancillary personnel to support administrative staff and teachers.
- Board Member: spoke of seeing security staff walking through the building in pairs; would prefer that we hire retired police officers who know what they are doing.
- Board Member: Q re: steps that were taken after the meeting with Bay Shore School District's security?
- Board President: As a result, security staff who were not doing their jobs were eliminated; looking to improve communication; Bay Shore invests more money in security
- Board Member: Q re: amount of money allocated for security?
- Board President: Money has been allocated for a Lead person in security; a candidate has been identified and interviewed.
- Discussion re: bids for cameras and Q re: putting a camera outside the Boys' gymnasium?
- Board Member: wants to see all staff involved in security; and for the district to pursue a relationship with the 3rd Precinct.
- Board Member: spoke of not knowing the responsible party when threats are written on bathroom walls...
- Board President: spoke of "Rights to Privacy" and areas where cameras are not permitted; said cameras will be placed in areas that are non-threatening to staff members.
- Q re: Additional AEDs?
- From 2004 to present, more money was spent on security

CONCLUSION:

- Compiling data for concrete plans
- Upgrading training for security guards; guards must be licensed professionals
- Making security jobs more site-specific
- Determination has not been made whether EXCEL will cover security staffing because everything under this Bond must be justified

OTHER

- Lori Klamut: fencing the field and playground to protect the students
- Bond Committee Chair: Estimates are being secured for fencing – current estimate for fencing the HS field: \$161 thousand.
- Q re: cost for landscaping?
- Bond Committee Chair: \$12 thousand for each building.
