#### 6. Q &A SESSION

Q: the CPR for this year?

A: 3.8

Q: Increase in transportation cost in light of the new contract?

A: \$4 - \$5 hundred thousand

Q: Teachers' salaries are up please explain?

A: This is a Rollover Budget; we have retained the same people; explanation of staff movement due to steps and earned credits were given

Q: Special Education program bringing revenue to the district?

A: The Autism and Life-Skills programs is expected to bring in revenue but they are in the preliminary stages

Q: It seems that the \$2 million increase from last year's budget is really 7% increase?

A: Vast majority of staff is moving down and across; and contract negotiations are ongoing.

Q: Explanation of the Fund Balance?

A: It shows a 3-year plan; we've reigned in spending; and have good management

Q: Has the district identified cuts in the event the budget does not pass?

A: Typically no. Although, cuts could be equipment, programs – no tremendous differences between the two

Q: Difference between Current and Contingent Budget amounts?

A: \$3.96 million to \$3.7 million

Q: Looking at the tax levy amount, how can the tax rate be the lowest on the Island?

A: Referencing the tax rate increase, not the tax levy.

Q: What are the percentages of tax rate increases in Nassau and Suffolk Counties?

Statement: Resident congratulated Mr. Buzzeo for a job well done.

Q: Salaries for only 3 department chairs?

A: Four Chairs are listed with stipends, not salaries

Q: Nothing budgeted for Supplemental Health Services

A: That budget line was left over from the past year

O: Salary line 2855?

A: The line below is blank – lines below have been reduced

Q: When Pilot monies arrived in the district?

A: January

Q & A

Q: Why not apply Pilot monies from the previous year to the budget? Why the application of future pilots?

Q & A [Cont'd]

A: Anticipated monies are now added; since the surplus has been created, this method can be applied; there is history and documentation to support these payments; pilot is revenue used to support the Budget Timeline - 2009-2010 Elections

Statement: Pilot money should be used for education, not salaries

Q: Is a 2% raise guaranteed for teachers if there is no contract?

A: There is no provision for increases for maxed-out employees, except those moving across with step increases

Q: Compensation for department chairs – referencing a presentation at the last BOE meeting?

A: In anticipation of this, funds have been incorporated into the budget.

Q: Budget to Budget is confusing – why not give an "actual" for the school year?

A: Always looking at projections; - it is too time-consuming to work on an actual; this involves quantifying land changes; the budget numbers for 2009-2010 is based on actual figures; documents were compared with previous year's numbers, but these numbers were not totally relied upon.

Q: The meaning of Trans. Underfunding – why the percentage increase?

A: Last year's figures indicated that it was \$400-\$500 thousand underfunded

Q: Does the budget include funding for the Alternative High School program?

A: Yes. Spending will total \$267,982

Q: Number of students slated for the alternative program?

A: There are 16 to 21 students; but the numbers will vary

O: Are the bus monitors that are listed, matrons?

A: No.

Q: Since there is large fund balance, why not give the taxpayers a 0% tax rate? Is the business office now staffed with qualified people?

A: The fund balance will be used to buffer future increases, maintain a strong academic base; and prevent employee layoffs. We have good administrators and staff; academics have moved to the forefront; the Auditor's report is available on our website. In response to your question about staffing for the business, the answer is yes. The business office is staffed with qualified employees.

Q: reference: a 1,200 discrepancy in the flyers that were mailed out?

A: The mistake was on the part of the printer

Q: The legal notice put forth by the school district asking the public to vote on a \$15 million Bond?

A: The district is eligible for additional aid which can be used to convert our buildings to solar power and for other improvements; \$8 million of this money will be dedicated to getting us out of the LIPA grid. There will be 0% to the residents because the district already has the funds.
