'This is a proposition requesting the South Country School District to reduce its current minimum mileages of ½ to 1½ miles (depending on grade) to 0. This proposition directly affects those who are currently deemed "walkers". The current number of walkers are 430. At least 9 full buses would be required at \$67,740.59 totaling \$609,665.31. The cost to the average homeowner is approximately \$1.11 per \$100 of assessed valuation. All figures are based on School District FOIL information"
